### **President's Report**

Dan met with David Ortiz about sewage and how to bring in the lines to all properties  
David Ortiz had recently met -with State Director of CAPA who reported that they have a partial plan-but there is no money allocated at this time. It is possible that we may know by the end of October if the connection underneath-the road will go ahead. The route for the pipeline into Akumal has not yet been determined. There is a need for pumping stations in Akumal Norte.

2. One guy got drunk, and guards intercept him by Crystal Azul- National Guards explained to CEA volunteer that they need to coordinate with them so they can be escorted and avoid problems.

There will be 3 access points for National Guards to access the beach. The board also noted that the NG need to work cooperatively with private security

## **Government Report**

First Stage for the regularization of North Akumal status has been completed. The initial cost of the contract with Ivan Hernandez was for 300,000.00 pesos but 2 documents are not yet necessary so up to \$100,000 pesos will not be required at this time.

Henning will coordinate the presentation to the Mayor in order to establish a joint working group with the municipality, to work on internal rules, and other requirements

It is anticipated that unknown costs arising from the working group over the next 8 months will be for 2023. The primary intention is to establish very close relations with the government and collaborate with them.
